**TIE WITH GRANDVIEW;  
WIN FROM RICHLAND**

High School Football Boys Wind Up a Highly Successful Season with Two Interesting Games

GRANDVIEW 6; KENNEWICK 6. The hardest game on the local field this season was played Friday, Nov. 22, with Grandview. This game when scheduled was with the high school, but several of the Grandview team dropping out made it impossible for them to bring a strictly high school team. Rather than call the game off Kennewick consented to the substitution of several town boys so the visiting team was much heavier and superior to the team that should have played.

This made no difference with the Kennewick boys. They went into the game determined to win. As soon as the ball was in play everyone knew the game would be close and hard. By a series of line plunges the ball was carried to the center of the field and lost on downs.

Grandview made twenty yards on a pass and with a double pass which found Kennewick's left end asleep, took the ball to the one-yard line. Gill plunged across for the only Grandview score. This did not dishearten the Kennewick boys. Twice the ball was carried over for touch downs by the Kennewick team but each time brought back. In the last quarter the ball was carried across for Kennewick's score, the game ending 6 to 6.

But for the poor work of the Kennewick ends in the first quarter the game would have ended 6-0 for Kennewick. Burmaster, a new man, found a place in the hearts of the spectators by his defensive work. Howe and Johnson were the only men to make distance for Kennewick.

KENNEWICK 39; RICHLAND 0.

Wednesday's game with Richland was a fitting close of a most successful season. The game was the best ever played on the home field. The score does not tell the story except to show the superiority of the local team. There was always enough opposition to make it a live game. The team spirit of the Kennewick boys was what made it the best game of the season. Always there was that determination to make another yard. The team work which has been flashy during the season was consistent and the interference which was lacking in the end runs in the Grandview game was perfect. The boys who played this as their last game with the local high school team may surely feel proud of their work.

It would be hard to pick any part of the game as the most interesting unless it might be the defense of the local team in the last quarter when the Richland team placed the ball on our five-yard line for the first down. Four times the line showed its ability, withstanding the hard plunges of the Richland team and the ball went over to the home team. Just to show that they were ashamed they quickly carried it to the length of the field for the last touchdown of the game.

The scoring started early. Kennewick received at the west goal. By a series of tandem plays the ball was carried to the center of the field when Oliver with perfect interference circled left end for a forty-yard run and a touch down. Goal

was not kicked. The second and third periods netted four touchdowns, Johnson and Howe each getting two. Oliver made another in the last quarter.

The new game was showed in all its phases. Forward passes were tried by both teams with about the same success. While the open work of the local team was spectacular and long gains were made with this style of play, it was by means of the bucks and heavy off tackle plays that the most consistent gains were made. It would be difficult to say which was most popular with the spectators. The fierce plunges through tackle were appreciated at any rate. Here the ability of Carnahan to make openings for his backs was very much in evidence.

To pick the stars of the game would be a difficult undertaking. It was team work which won. Every man played hard, clean ball and every man deserves credit.

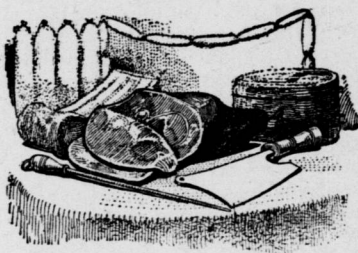
